# NBRC Announces Combined \$24 Million in Fall 2024 Awards Through Catalyst, Forest Economy, and Timber for Transit Programs

CONCORD, N.H. (January 23, 2025) – Today, the Northern Border Regional Commission (NBRC) announced just over **\$24 million** in new awards as part of the Commission's Fall 2024 round of funding across all three of its competitive programs. The 37 new awards will benefit communities throughout the Commission's member states of Maine, New Hampshire, New York, and Vermont.

Awards made per program include the following:

- **\$20.6 million** awarded through the Catalyst Program, including 18 projects expanding the region's critical infrastructure and 15 projects building a diversified economy and competitive workforce.
- Two awards totaling **\$1.9 million** awarded through the Forest Economy Program (FEP) include expanding forestry workforce initiatives and support for an immersive high school forestry program.
- Two awards totaling \$2.28 million awarded in the Commission's new Timber for Transit (T4T) Program
  will support replacing deteriorated bridge materials with wood-based materials and composites, as well
  as the design and construction of an outdoor hybrid timber pavilion for year-round small business use.

"Community centered economic development is at the heart of NBRC's work. What's consistent about all the projects receiving funds from the Commission's fall competition is that they will create economic opportunity and improve day-to-day life for the people who call this region home," said **Chris Saunders, Federal Co-Chair of the NBRC.** 

Forest Economy Program awards support workforce and education in Chittenden County, VT and Kennebeck County, ME:

"VYCC is excited to participate in the NBRC Forest Economy Program! These funds will increase the number of young adults working and learning in Vermont's forest over the next three years. With a broad array of partners, we can enhance training outcomes and connect our participants with employment opportunities. We look forward to increasing our collaboration with regional land managers and strengthening relationships with workforce partners in the forest products industry," said **Patrick Pfeifer, Conservation Program Director at Vermont Youth Conservation Corps**.

"The Forestry Immersion Program has quickly demonstrated its incredible value and ability to inspire the next generation of Maine's forest workforce. With funding from the Forest Economy Program, we will work with our partners to expand this initiative, offering students across the state the chance to immerse themselves in the forest and experience the immense potential for a fulfilling and vibrant career in Maine's forest sector," said **Logan Johnson, Executive Director, Maine TREE Foundation**.

Timber for Transit awards will support local road safety and economic development goals in Sullivan County, NY and Cheshire County, NH:

"Maintaining our roads and bridges increases in cost every year, so this funding announcement is welcome news," affirmed **Sullivan County Manager Joshua A. Potosek**. "Replacing the Flugertown Road bridge will not only make it safer and more durable but also ensure continued access to some of the wildest, most unspoiled landscapes in Sullivan County. We rely on the dollars generated by the thousands who come to enjoy our natural resources throughout the year, and thanks to NBRC and Senators Schumer and Gillibrand, those resources will remain some of our star attractions."

"The Timber for Transit grant opportunity has so much potential for our region, and I am thrilled that Keene will have this opportunity to showcase that. One of our economic development goals is to activate areas such as Gilbo Avenue and help people take advantage of our recent land use code updates. The new pavilion is a perfect way to launch that effort that may not have otherwise been possible," said **Elizabeth Dragon, City Manager**.

Catalyst Program awards include improvements to water and street infrastructure in New York's Lewis County, primary care support in Vermont's Windham County, and the construction of an anaerobic digester at a potato chip production plant Maine's Aroostook County:

# Fall 2024 Catalyst Program Awards

NBRC's Catalyst Program exists to stimulate economic growth and inspire partnerships that improve rural economic vitality across the four-state NBRC region.

### **Maine**

#### **Awarded to: Loring Development Authority**

Project: NBRC funds will be used for the construction of an anaerobic digester. This initiative aims to enhance the Loring Commerce Centre's appeal to a prospective \$60,000,000 potato chip production plant, earmarked for the site of the former Loring Air Force Base in Limestone, Maine.

#### Awarded to: City of Presque Isle

Project: NBRC funding will be used to upgrade the commercial kitchen at The Forum, a city-owned building which is an important year-round, multi-use large event venue. Upgrades to the kitchen will allow the city to expand the number and types of events held at The Forum, bringing in tourist and recreation opportunities. The building also serves as an emergency shelter for all of Central Aroostook due to its location and capacity to serve 5,000 individuals.

#### Awarded to: RSU 38 - Maranacook Area Schools

Project: Development of a driving range for Commercial Driver Licensing will allow for two CDL vehicles to train students at the same time and provide a training location that is not shared with other school or public traffic. The CDL range expansion will train students faster and more efficiently, decreasing the current training cycle from four to three months. The added range size will also facilitate the eventual expansion into class A truck driver training.

#### **Awarded to: City of Augusta**

path.

As part of this project, start-ups will receive technical assistance as well as access to loans.

#### Awarded to: YMCA Alliance of Northern New England

Project: Funding will be used to conduct a 4-county (Cheshire, Sullivan, Belknap, Carroll) childcare workforce recruitment campaign. In those 4 counties, only 12% of YMCA programs are fully staffed, while currently serving 24,000 children. This initiative is slated to produce a 50% increase to YMCA staffing in the affected counties.

#### Awarded to: Whitefield's Official Library Friends

Upon completion, this center will feature hybrid space for large and small group meetings, a business center, a staffed information hub, kitchenette and water filling station, public bathrooms, Wi-Fi and computer access, and AC/heat. These improvements will assist the library in providing services to the surge of new library users they have seen since Covid (such as home-based and remote workers).

Two breakages in the last year cut service for significant periods of time, making this repair necessary and critical to the economy of the town.

Upon completion the facility will be capable of hosting 24 people and flight simulators/ground support for gliders. These simulators are also intended to be used by local technical education centers.

The facility itself will host 25-30 new jobs and integrate with the Geisel School of Medicine and other local educational institutions to offer preceptorships.

This project aligns with the North Country Regional Economic Development Council Strategic Plan goal of upgrading infrastructure to support economic development and will result in an improved municipal water system that meets state DOH and DEC regulatory compliance. Funding will also help increase the capacity of the water system to meet the needs of the existing district and support future growth within the hamlet, a gateway community to New York's High Peaks and Olympic Region.

#### **Awarded to: Adirondack Medical Center**

Project: The Adirondack Health Telecommunications Expansion Project will allow Adirondack Health, the largest private employer in the Adirondack Park to make cutting-edge upgrades and enhancements to critical security, networking, and telecommunications software and hardware which will enable the hospital's healthcare providers to reach rural residents throughout its vast service area. The project will take place at Adirondack Health's main hospital facility in Saranac Lake and provide benefits to at least five sites within their service area, including the communities of Saranac Lake, Lake Placid, Tupper Lake, St. Regis Falls, and Keene. The project will increase Adirondack Health's ability to see patients via telehealth and to treat in-person patients with improved efficiency and reliability.

Project: The Village of Constableville will improve community connectivity and inclusivity through a two-stage

The water infrastructure project will include right sizing drains, expanding coverage zones, and replacing aging cast iron lines, much of which is over 100 years old. The implementation of the Complete Streets Plan, the second phase of the project, will improve access to key community assets such as public facilities and businesses by making pedestrian travel safer and more appealing for both residents and visitors, including the aging population, young children, and those with disabilities. The Complete Streets Plan is a result of longstanding community planning initiative and community input, including the Lewis County Comprehensive Plan prepared in 2009 and the Lewis County Complete Streets Plan prepared in 2023.

#### **Awarded to: Adirondack Community College**

Project: The State University of New York (SUNY) Adirondack Community College will complete Phase 1 of a wastewater infrastructure improvement project on campus. The wastewater study will allow the college to identify a more efficient wastewater discharge route that reduces risk failure. Results of the wastewater study will inform the construction design and produce a scope of work and budget for a Phase 2 construction project.

Adirondack Community College (ADK) serves Warren and Washington counties in Upstate New York, an area that includes many low-income and rural communities. The project goal is to complete critical infrastructure improvements so that the college can continue to serve its communities and service area. With over 416 employees, ADK is one of Warren County's largest employers and contributes significantly to the local economy through its payroll and spending patterns. In addition, as the only open-access educational provider within a 55-mile radius, ADK is the primary vehicle for educational opportunity and economic mobility for many community members, especially those who are economically disadvantaged.

#### **Awarded to: Northern Area Health Education Center**

Project: The Northern Area Health Education Center (NAHEC) will improve access to quality health care by promoting improvements in the supply, training, development, and distribution of health professionals in a 5-county area. NAHEC's Institute for Career Advancement in Medicine (Institute) is an innovative initiative designed to tackle the acute shortage of healthcare workers in Northern New York, a region characterized by its rural landscapes, economic challenges, and limited access to healthcare services. In 2024, NAHEC completed the development of a digital platform, to serve as a hub for all training, resources, and community engagement activities. The platform is user-friendly and accessible, ensuring individuals from diverse backgrounds can navigate and utilize its features effectively.

The requested funding will provide the necessary resources to fully implement the Institute's plans, including the continued development and deployment of the digital platform, the creation of new career pathways, and the extensive outreach efforts required to engage the region's diverse population. Funding will support services to vulnerable populations, including those in the Mohawk Territory, where both healthcare access and economic opportunities have been persistently limited. The Institute aims to address current workforce shortages while also establishing a sustainable pipeline of healthcare professionals capable of meeting the region's needs for years to come.
