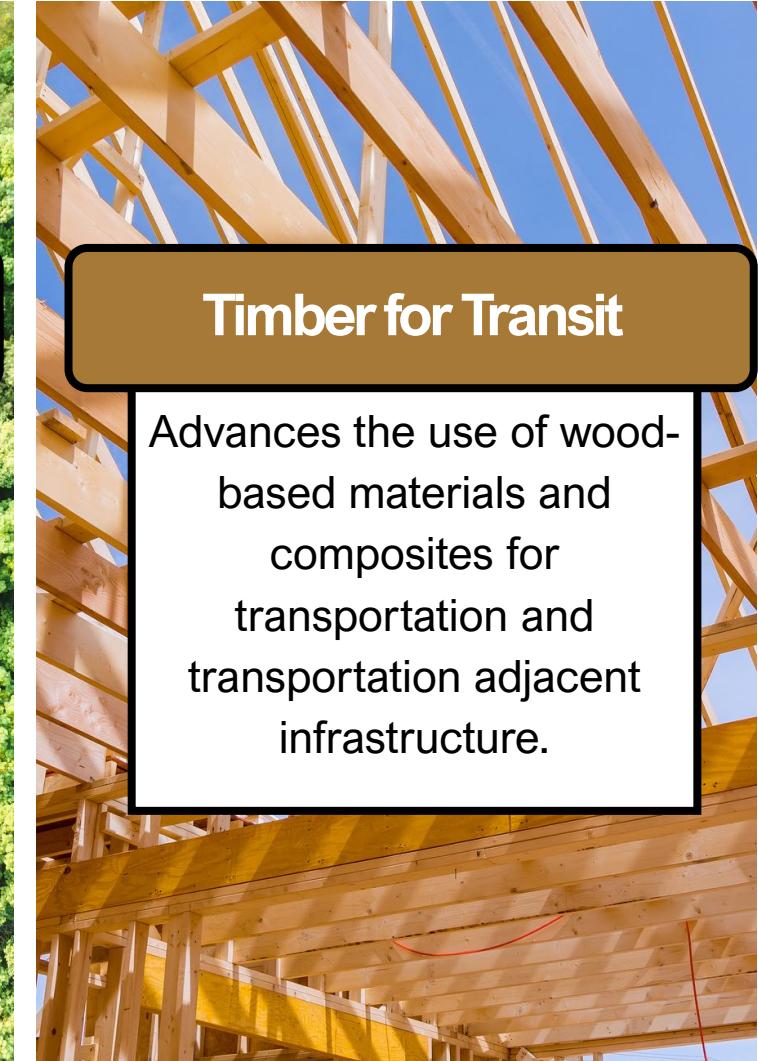
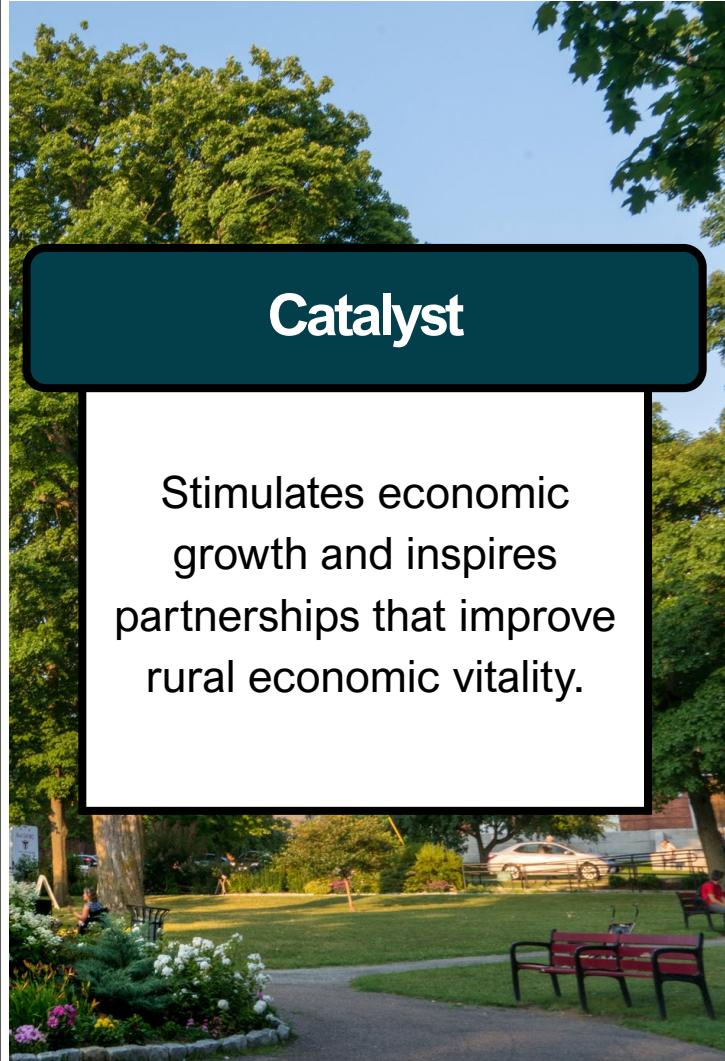

# Determining Eligibility & Match



1. Determine organization eligibility
2. Determine if project location and applicant/co-applicant are in NBRC Service Area. Determine if your project will require waiver submission at pre-application.
3. Identify reimbursement and match rate associated with location.

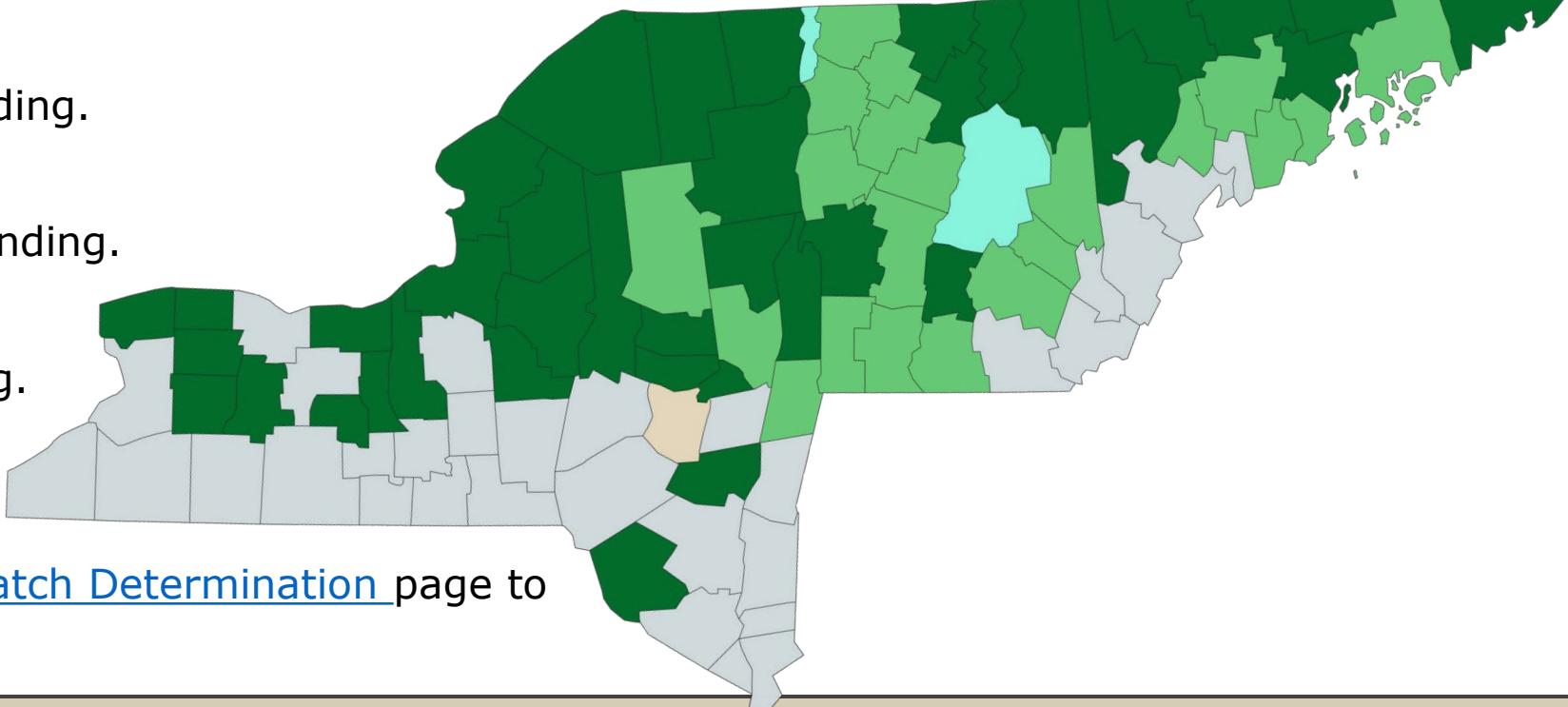
For-profit entities, LLCs and other entities that are not a 501(c) are not eligible to apply for funding.



# GEOGRAPHIC ELIGIBILITY

Your project may be eligible for NBRC funds if it is located within one of the counties in our service area. Each year, the NBRC assesses the level of economic and demographic distress within our service region. This helps determine whether the Commission can provide grants within a county as well as what level of match is required of Commission-funded projects.

- **Distressed:** Eligible for 80% funding.  
Requires a 20% match.
- **Transitional:** Eligible for 50% funding.  
Requires a 50% match.
- **Attainment:** Ineligible for funding.  
(Some exceptions apply.)

## 2026: NEW Match Rate Determination

**Background:** Match rate (as mandated by Congress) is determined by the socio-economic indicators of your geography. Each assessment level has a corresponding match rate requirement.

**Simplifying Terms:** From “match and cost share” to just “match”. Large and complex projects may choose to phase the work.

**Getting More Granular:** Beginning in 2026, NBRC evaluates distress in the region at both a county *and* community level, providing applicants with the option to choose the match rate that is most beneficial based on their project location(s).

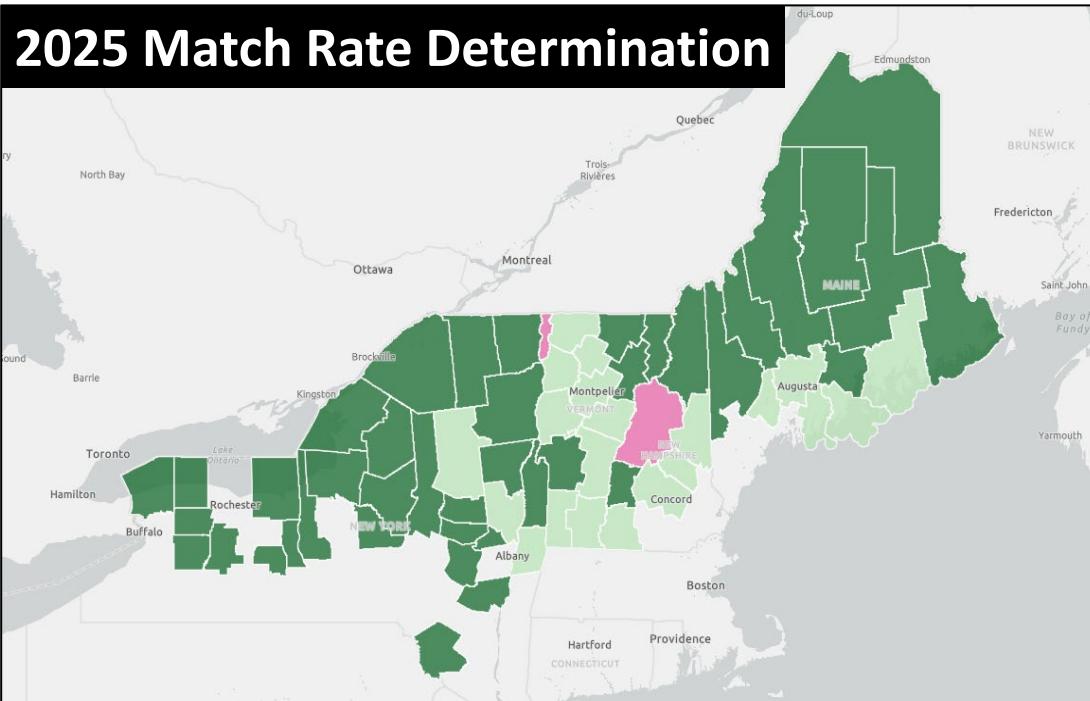
**NBRC's 3 Match Tools:** New tools have been developed to assist applicants in identifying their match rate.

# Determining Match Rate Based on Project Location

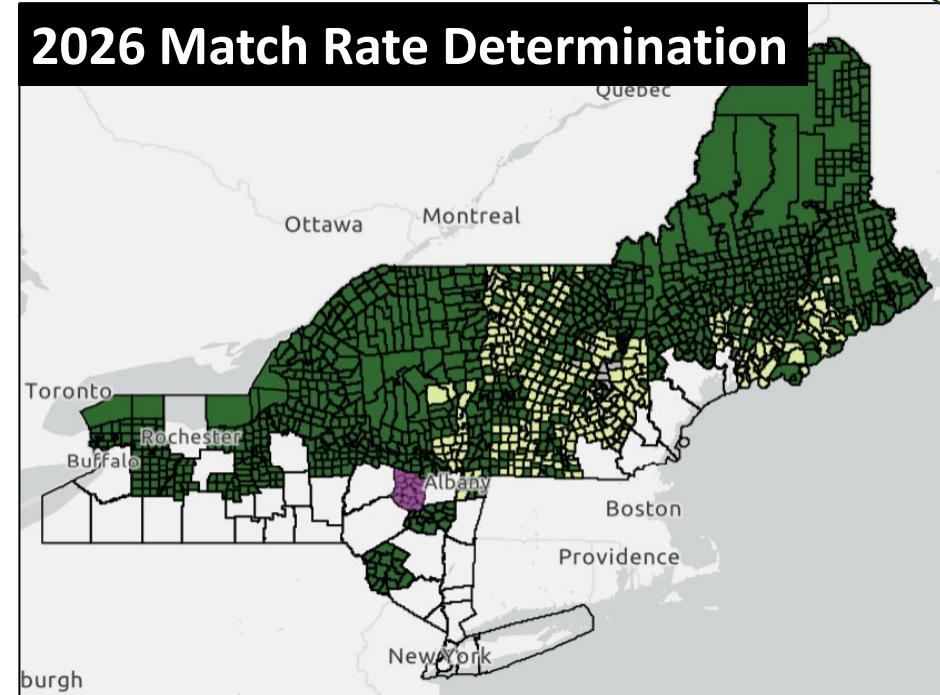

# Previous Award Recipients

An eligible applicant with an open or active NBRC award cannot receive an additional NBRC investment until the current award has both

- submitted reimbursement requests totaling 75% or more of the project and
- demonstrated that 75% of the match has been expended before the pre-application deadline

If the 75% expenditure requirement cannot be met, the applicant can apply for a waiver. The **75% Expenditure Waiver** must be submitted together with the pre-application.

# Applicants Outside NBRC Service Area

Entities eligible for a **Significant Benefit Waiver** are those who:

- Are located within an Attainment County but not within a Distressed or Transitional community, or
- Are located outside of the NBRC region but within a member state.

Entities eligible for a Significant Benefit Waiver must demonstrate the project will bring significant economic benefits to NBRC Distressed or Transitional communities or counties.

# Local Development Districts

All NBRC competitive program awards require the use of a Local Development District (LDD) for grant administration.

✓ Exception for state government entities and LDDs

LDDs are compensated for grant administrative work. The fee structure is as follows:

- \$8,000 flat fee for awards of \$400,000 or less
- 2% of NBRC requested amount for awards above \$400,000.

# Program Purpose

The Timber for Transit Program is designed ***to advance the use of domestic forest products in transportation infrastructure*** projects across Maine, New Hampshire, New York, and Vermont ***to showcase the capabilities of wood*** in these applications.



# Available Funding



The Northern Border Regional Commission may award up to \$14 million, available for projects that demonstrate the capabilities of wood in transportation infrastructure\*.

Timber for Transit funding will be competitively awarded in two funding rounds

# Timeline and Key Dates

## Spring Round

- Pre-applications AND Waivers  
Due: **February 27, 2026**  
**(before 5:00pm EST)**
- Full Applications Due: **April 17, 2026 (before 5:00pm EST)**
- Grant Awards Announced:  
**June 2026**

## Fall Round

- Pre-applications & Waivers  
Due: **August 28, 2026 (before 5:00pm EST)**
- Full Applications Due:  
**October 16, 2026 (before 5:00pm EST)**
- Grant Awards Announced:  
**December 2026**



# Program Eligible Purposes

## Feasibility

Early-stage activities—such as planning, inventory assessments, engineering, design, cost benefit analysis, permitting, site assessments, and environmental assessments are **eligible for up to \$1,000,000**

## Implementation

Construction— such as assets and facilities that align with Timber for Transit program priorities are **eligible for up to \$5,000,000.**

(Projects in this category requesting more than \$1,000,000 must meet the program's higher maximum requirements.)

# Timber in Transportation Infrastructure

Common examples...

- Vehicular and pedestrian bridges utilizing domestic wood components such as glue laminated timber (GLT) or composite decking
- Transportation and adjacent structures such as airports, highway rest areas, train depots/stations that utilize cross laminated timber (CLT)
- Outdoor recreation applications such as trail bridges, pedestrian walkways, welcome centers





# Requesting the Higher Maximum

Projects requesting **more than \$1,000,000** must address the higher maximum requirements. NBRC will consider awards up to \$5,000,000 for projects that demonstrate at least one of the following:

- Project demonstrates alignment with two or more of the [Program Investment Priorities](#) of the program
- Project has been identified by NBRC or a State(s) as addressing a time-sensitive issue of magnitude or severity that will be addressed by the proposed project
- Construction takes place in two or more eligible communities/counties/states

# NBRC Evaluation Priorities



- Commit to utilizing domestically sourced timber
- Demonstrate evidence of planning for extreme weather readiness, including but not limited to carbon capture, increased frequency and intensity of storm events, and sea level rise
- Utilize projects as a tool for university and industry education and training

# NBRC Evaluation Priorities

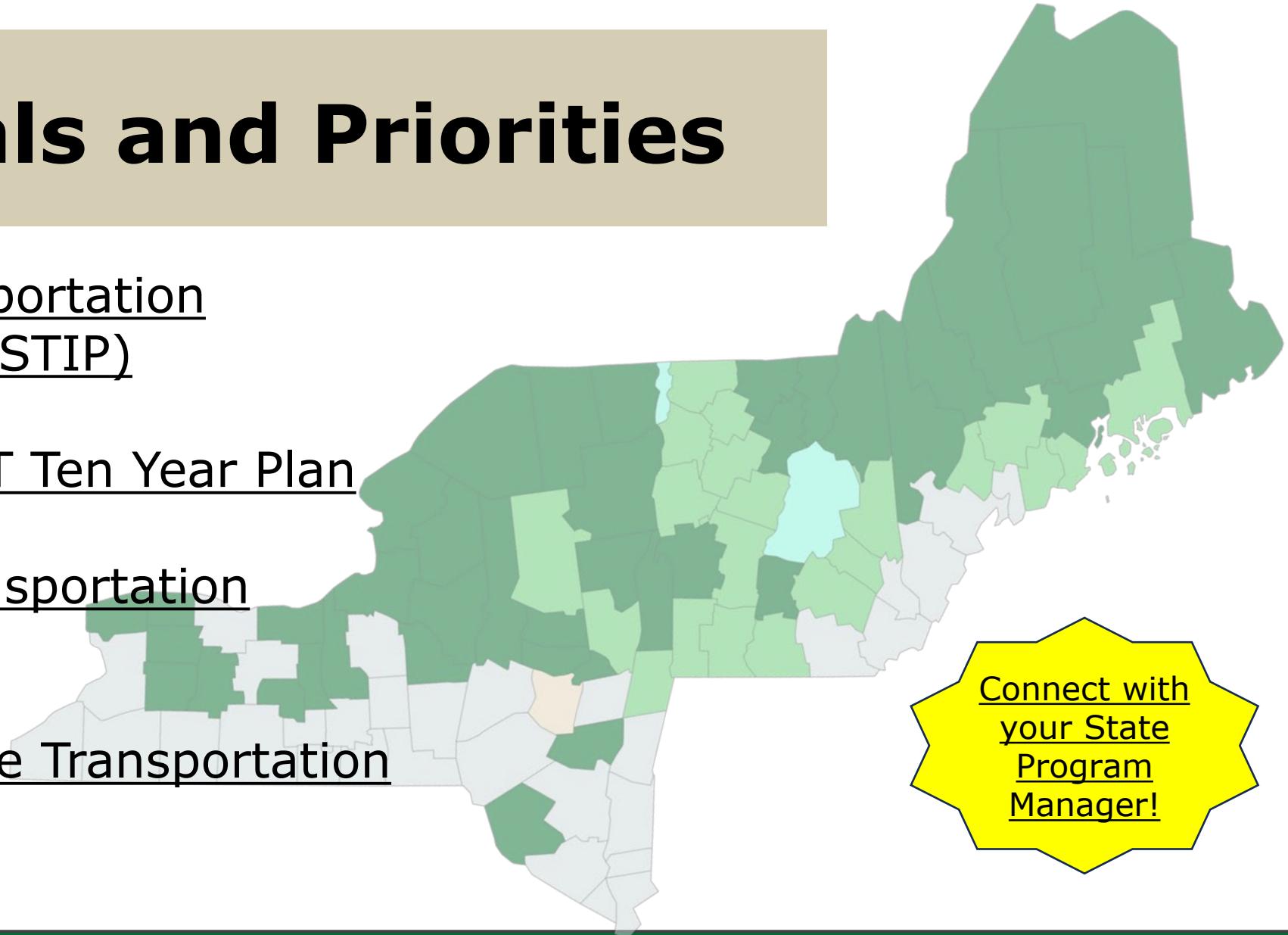
- Demonstrates alignment with state and community initiatives.
- Include promotion/publication/marketing as part of their project deliverables
- Support, benefit, or engage communities that are impacted by specific socio-economic indicators.

# FUNDED PROJECTS

## VT Agency of Transportation

Franklin County, VT  
(Feasibility)

### Project Description

Feasibility study for a new Welcome Center near the Canadian border in Highgate. The study will evaluate site suitability, use of advanced wood products, and renewable heating options for the facility.

## Town of Sand Lake

Rensselaer County, NY  
(Implementation)

### Project Description

Replace the Johnny Cake Lane bridge with a climate-resilient structure to improve hydraulic capacity, accommodate two-way traffic and pedestrians, and enhance safety and access for locals.

## Town of Island Falls

Aroostook County, ME  
(Implementation)

### Project Description

Connects a community park to downtown via a Glue Laminated timber pedestrian bridge constructed using hemlock sourced from the town's 9,000-acre forest.

# Pre-Application: Process

**All pre-applications must be submitted using NBRC's online grants management system.**

- Requires registration (establishing a new user account, if not already established). Registration guidance document is available.
- You must “Qualify” for a funding opportunity to create your pre-application. Pre-application guidance document is available.

- Applicant Organization

- Address
- Employer Identification Number (EIN)
- Unique Entity ID (UEI) - Applicant must enter a UEI to complete registration. Go to Sam.gov to receive your UEI.



This info will be collected during GMS registration.

*This information will be requested as part of the registration process and transferred to the pre-application.*

# Pre-Application: Requirements

# Pre-Application: Requirements

## Budget Narrative

- Description of expenses over \$5,000 by category
- Table describing match sources: source, federal v non-federal, and status of match

## Budget Details

- Requested NBRC funds
- Match and Cost Share funds
- Total Project Costs

**This info is submitted in the GMS. There are no additional budget documents to upload for pre-application.**

**Funds will need to be allocated across budget categories**

# Pre-Application: Requirements

## Pre-application budget categories

- Personnel
- Fringe Benefits
- Travel and Transportation
- Equipment
- Supplies and Materials
- Consultants
- Contracts and Sub-Grantees
- Construction
- Other Direct Costs
- Indirect Costs

- These budget categories align with the SF-424cbw.
- Pre-applications DO NOT require the SF-424cbw form, but full applications (by invitation only) will.

# Pre-Application: Requirements

## **Narrative Questions:**

- Project Abstract
- Project Goals, Outcomes and Outputs
- Program Investment Priorities
- Project Beneficiaries and Community Context
- Statement of Need
  
- All narrative text boxes have a 5,000-character limit and formatting/editing capabilities.
- Applicants encouraged to have narrative responses available in a word processing document to easily copy and paste into the pre-application.

# Pre-Application: Requirements

## **Project Abstract – Narrative**

- Provide a summary of the proposed project.
- What NBRC eligible purpose and project category does this project address?
- Describe the status of the project – ready for implementation, planning tasks ongoing, early stages.
- What is the project scope? Over what period of time will this project be completed?

# Pre-Application: Requirements

## **Project goals, outcomes, and outputs - Narrative**

- What are the expected economic outcomes (e.g. impacts on jobs, employment and wage growth) of this project
- Describe the scale of expected economic impacts on the community, county, or region

# Pre-Application: Requirements

## **Program Evaluation Priorities - Narrative**

- Identify and demonstrate how the project addresses program Evaluation Priorities.
- Identify and demonstrate how the project addresses relevant state priorities.

# Pre-Application: Requirements

## **Project Beneficiaries and Community Context - Narrative**

- Who will benefit?
- Why does this project matter to the community?
- If applicable, how does this project serve or benefit rural communities with populations of less than 5,000 or underrepresented communities?
- If applicable, how does this project help communities plan for extreme weather readiness?
- Address whether/how the project supports regional, state, or local transportation planning efforts.

# Pre-Application: Requirements

## **Statement of Need - Narrative**

- What is the challenge or problem the project seeks to address?
- What is the proposed solution?
- Why is this project important?
- Describe the opportunity gained by funding this project now.
- Why is NBRC funding important for this project?

# Evaluation of Pre-Applications



NBRC and the States will consider a project's alignment with the funding priorities for these program dollars when both issuing invitations to apply at the pre-application phase and in scoring projects at the application phase.

# Pre-Application: Evaluation

When issuing invitations to apply at the pre-application phase, NBRC and the States will also consider:

- the costs and expected benefits associated with the requested NBRC investment;
- the projects identified as a state priority;
- the benefits provided to the broader community and region.

# Pre-Application: Evaluation

## **State Program Manager Role**

- Project Development
- Review and assess pre-applications for alignment with Timber for Transit Program priorities and local and state transportation initiatives and planning efforts
